JUDICIAL EVALUATION POLL

HARRIS COUNTY CRIMINAL LAWYERS ASSOCIATION

FEBRUARY 2026



The Harris County Criminal Lawyers Association (HCCLA) conducted a judicial evaluation poll of the Association's membership between January 26, 2026 and February 11, 2026. A questionnaire was sent to all members of the Association by electronic mail. Of the 635 members of the Association, 92 responded to the questionnaire. The Poll included 16 Harris County Criminal Courts at Law and 29 Harris County Criminal District Courts. The tables contain the number of ballots and responses each judge received, which show the total number of lawyers who responded to at least one question for that judge. Members were given the option of "No Opinion" for each question. The "Yes%," "Sometimes%," and "No%" opinion columns represent the percentage breakdown of the number of those responses for each question only. The difference between responses (far right column) and number of ballots on any given question is attributable to the "No Opinion" responses. Results were rounded. The results of the poll were summarized as soon as practicable and communicated to the members of the Association.

The Harris County Criminal Lawyers Association (HCCLA) Judicial Evaluation Poll is not a scientific survey. It is a non-partisan poll by current members of the Association and has no bearing on any election. HCCLA does not endorse any judge or candidate for judicial office, and the results of the poll are not an endorsement by the Harris County Criminal Lawyers Association. The poll is intended to improve the criminal justice system and better inform the public about the judiciary in Harris County Criminal District Courts and Harris County Criminal Courts at Law.
